

All delegations are required to submit a Registration Form outlining

delegation will be limited to five (5) minutes unless otherwise determined by the Board of Trustees.

- h) Delegations deviating from the subject matter set out in the applicable registration form will be ruled out of order, however an individual making a delegation may answer questions asked by Trusteesnyttopic.
- During both public and In Ameria Meetings, it is the responsibility of the Chair to stop or caution the delegate if they begin to make specific derogatory comments about any person. The Chair will remind the delegate of the requirement to avoid negative, critical, or derogatory words and to focus on their concerns with respect to an issue or decision. If the delegate will not comply, the Chair may rule the delegation out of order. If the delegate becomes unruly, the Chair, rimatheir absolute discretion, remove the delegate(s) from the meeting for improper conduct in accordance with the ducation Act.
- j) If the Board of Trustees refers a matter to Staff, through the Director/Secretary, in respect of which a submission or deation is made, the Director/Secretary shall ensure the persons involved in the delegation are informed of the time and date at which the Staff report on the matter is to be reviewed by the Board of Trusteesor Committeeand information may be shared with the persons involved in the delegation in the discretion of the incomplete in the delegation.
